Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to generate sustained capital appreciation. To achieve this, the fund invests in equities, interest-bearing securities, convertible debentures, warrant-linked bonds, warrants, dividend-right certificates (Genussscheine) and index certificates of domestic and foreign issuers. At least 51% of the fund comprises mortgage

bonds, municipal bonds or other bearer bonds issued in a member state of the European Union or in another state that is a party to the Agreement on the European Economic Area. The selection of the individual investments is at the discretion of the fund management. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified

in category 3 because its share price fluctuates comparatively little and the likelihood of both losses and gains is therefore relatively low. The following risks could be of particular significance for the fund: The fund invests in equities. Equities are subject to strong price fluctuations and thus also to the risk of price decreases. If the guarantor becomes insolvent, this may void the guarantee. The fund invests in bonds, the value of which depends on whether the issuer is able to afford its payments. The deterioration of credit quality (ability and willingness to repay) may have an adverse affect on the value of the bond.
