Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to focus on hard currency bonds of emerging markets and their earnings potential. In order to achieve this, the country mix can be adjusted depending on the market assessment. Interest-bearing securities denominated in euro or another major currency (e.g. U.S. dollars), for example, in which currency risks are hedged, are considered. Derivative financial instruments may be used for both

investment and hedging purposes. The fund bears the fees for buying and selling securities. They are incurred in addition to the percentages listed under "Costs" and may reduce the fund's yield. In this context, the selection of individual investments is the responsibility of the fund management. The currency of the fund is EUR. The fund distributes annually. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified

in category 3 because its share price fluctuates comparatively little and the likelihood of both losses and gains is therefore relatively low. The following risks could be of particular significance for the fund: The fund invests its assets in selected regions or sectors. This increases the risk that the fund may be negatively influenced by the economic and political conditions in the respective regions or sectors. The fund invests in bonds, the value of which depends on whether the issuer is able to afford its payments. The deterioration of credit quality (ability and willingness to repay) may have an adverse effect on the value of the bond.

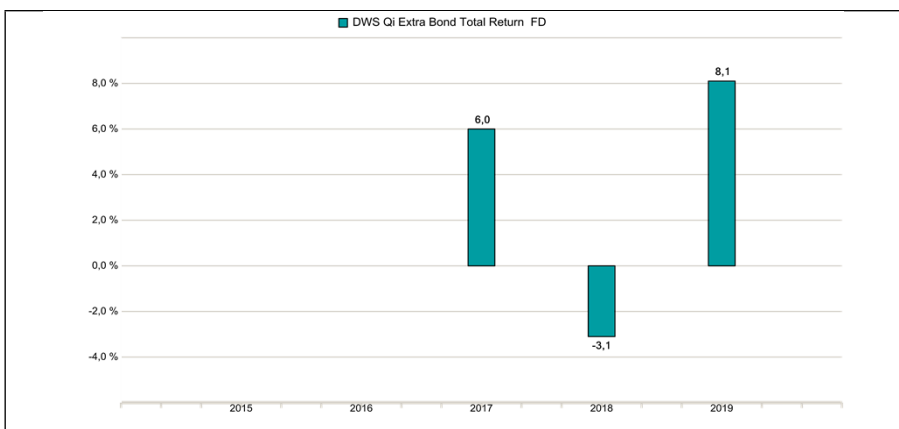
Charges
