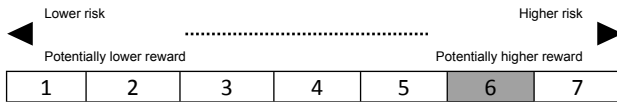

Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to achieve sustained capital appreciation. In order to achieve this, the fund invests primarily in equities of domestic and foreign issuers that are active in the provision of forward-looking infrastructure and the production of future-oriented industrial goods sectors and that

derive at least 20% of their turnover from these sectors. In this context, the selection of individual investments is the responsibility of the fund management. The currency of the fund is EUR. The fund distributes annually. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a

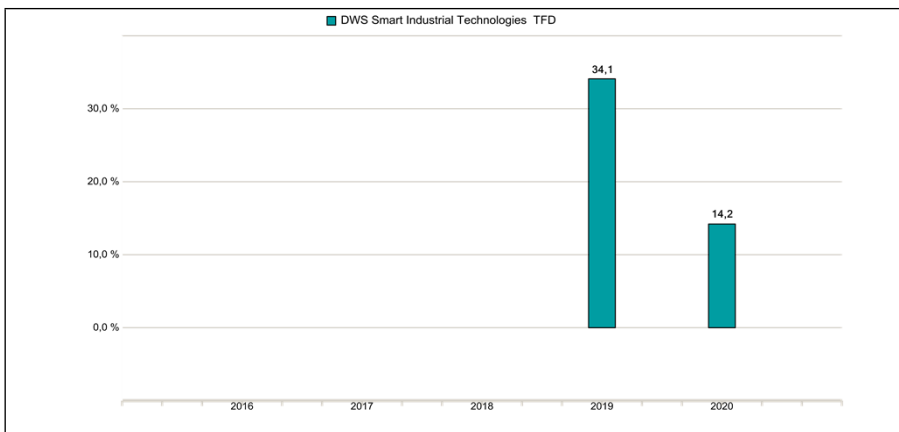
The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
