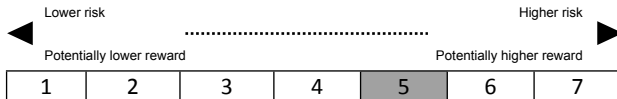
The management company is DWS Investment GmbH, a member of the DWS Group.

### Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to generate the highest possible appreciation. To achieve this, the fund invests predominantly in equities of domestic and foreign issuers. Companies that meet rigorous requirements in terms of market position, growth potential and current business strategy are particularly selected. Besides investing in equities, the fund invests

in interest-bearing securities, certificates, funds, derivatives and money market instruments. The fund management does not use any benchmark for managing the fund. In that context, the fund management is responsible for selecting the individual investments. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

### Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a

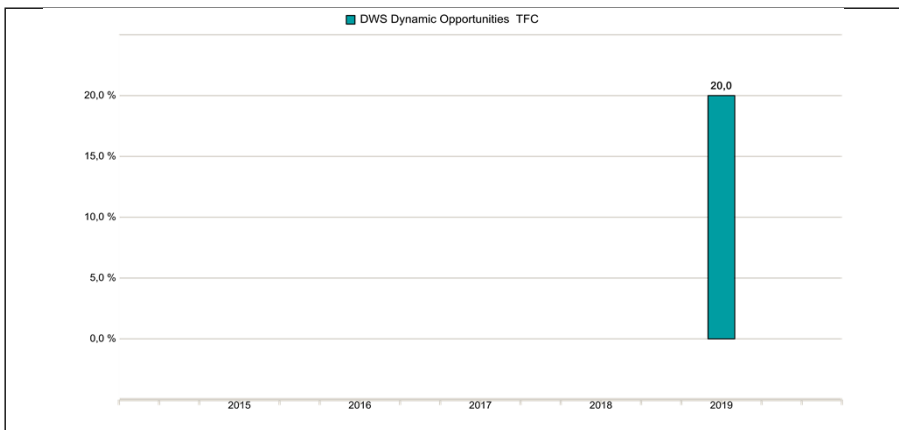
The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
